



MEMORANDUM of UNDERSTANDING

between

The Maria Grzegorzewska University
Warsaw, Poland

and

V. N. Karazin Kharkiv National University
Kharkiv, Ukraine

The Maria Grzegorzewska University, having its legal address at Szczęśliwicka 40 Street, 02-353 Warszawa, Poland, (hereinafter referred to as the **ASP**), represented by **Rector**, Prof. **Barbara Marcinkowska** acting on the basis of powers available to her

and,

V. N. Karazin Kharkiv National University, having its legal address at 4, Maidan Svobody, Kharkiv 61022, Ukraine (hereinafter referred to as the **Karazin University**), represented by **Vice-rector** for Research and Teaching **Zarif NAZYROV**, acting on the basis of an attorney from September 4, 2024 № 0102-39/30,

Hereinafter collectively referred to as the Parties and individually as a Party,

Willing to establish collaborative relations to develop academic and cultural engagement in learning, teaching and research activities, have entered into the Memorandum of Understanding (hereinafter referred to as the MoU) on the following:

1. Both Parties shall encourage cooperation in academic sphere.
2. Both Parties shall seek to promote activities, such as:
 - 2.1. Exchange of academic and administrative staff;
 - 2.2. Exchange of bachelor, master, doctoral and postdoctoral students;
 - 2.3. Joint academic programmes (including double degree programmes);
 - 2.4. Joint research projects and common scientific initiatives, such as seminars, lectures etc.;
 - 2.5. Joint internship programmes;
 - 2.6. Exchange of publications, reports and other academic information;
 - 2.7. Use of research equipment and free access to the facilities of either Party;
 - 2.8. Collaboration on continuing education programs and certificates
 - 2.9. Other activities as mutually agreed.
3. The details of co-operation and the associated financial arrangements for each specific area of activity shall be settled through consultations between the Parties and shall be spelled out in separate Appendices which should be attached to this MoU and form its integral part.

4. This MoU does not form any legally binding obligations between the Parties, nor does it place financial responsibility or funding commitments on either Party.
5. If a dispute arises from any part of this MoU or related addenda that cannot be resolved to the satisfaction of either Party, this MoU will be terminated. At any time, either Party may terminate this MoU by providing at least six (6) months' advance written notice. Such termination will permit the completion of activities in progress under the terms of the related addenda, unless agreed otherwise between the Parties.
6. This MoU will become effective from the date of the last signature and will remain in force for a period of five (5) years. The MoU may be renewed upon agreement of both Parties in writing and signed by the appropriate authorities for further periods of five (5) years.
7. The MoU is entered in two (2) copies in the English language. Each Party shall retain one (1) copy of the MoU.
